 - There are currently 56 benefitting veterans, and
 - 35 Dependents of veterans enrolled
 - If they self-advise, they run into money problems, i.e. if they are taking 9 classes, and 3 are not in major, those 3 will not get paid, however...

- Other Scholarships are available at the student level, would cover tuition & fees, there are Vietnam Veteran Scholarships of which some are not aware.
- Chapter 33 Benefits—**fulltime** benefits can be \$_000 to \$1400 per month, **part**-time, \$300 to \$900 per month, depending on what chapter they fall under and number of credit hours they are taking.
